### WHAT IS RECLAMATION

Reclamation fill is defined as uncontaminated, non-water soluble, non-decomposable inert solid material. This includes soil, rock, gravel, brick\*, block\*, concrete\* and incidental asphalt\*\*.

No painted surfaces. \*\*25% or less per load.

\*No protruding rebar.

The management of fill is heavily regulated by the Pennsylvania Department of Environmental Protection (PADEP). Miller Quarry & Asphalt inspects every load of inbound material and conducts routine testing to ensure the material meets all reclamation fill criteria, and permit-specific conditions.

## **TERMS & CONDITIONS**

All sources must complete a Reclamation Fill Source Approval Form, available online at www.reclamationfill.com.

All sources require pre-approval. Sources may require laboratory analysis.

Large sources require DEP Approval.

Material originating from an industrial or commercial site, sites containing underground storage tanks, "Act 2" clean-up sites, or superfund sites, will not be accepted, without prior characterization/lab analysis.

Each load requires a pre-printed load form to be executed by the material originator/contractor/hauler, which states that the signee is responsible for certifying that the material meets all reclamation fill regulations.

Miller Quarry & Asphalt reserves the right to reject any load for any reason.
